### Precautions for safe handling

#### Protective measures

Put on appropriate personal protective equipment (see Section 8). Concentrations of mist, fumes and vapours in enclosed spaces may result in the formation of explosive atmospheres. ## Section 8. Exposure controls/personal protection

<b>Hand protection</b>	Wear protective gloves if prolonged or repeated contact is likely. Wear chemical resistant gloves. Recommended: Nitrile gloves.
