Methods and materials for containment and cleaning up

Small spill

Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Store in accordance with local regulations. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Section 8. Exposure controls/personal protection

Appropriate engineering controls

All activities involving chemicals should be assessed for their risks to health, to ensure exposures are adequately controlled.
