### Methods and materials for containment and cleaning up

### Precautions for safe handling

#### Protective measures

#### Advice on general occupational hygiene

#### Conditions for safe storage

Store in accordance with local regulations. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. ### Hand protection

Wear protective gloves if prolonged or repeated contact is likely. Wear chemical resistant gloves. Recommended: Nitrile gloves.
