Injuries may not appear serious at first but within a few hours tissue becomes swollen, discolored and extremely painful with extensive subcutaneous necrosis. Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Small spill

Appropriate engineering controls

All activities involving chemicals should be assessed for their risks to health, to ensure exposures are adequately controlled.
