### 8.2 Exposure controls

#### Appropriate engineering controls

#### Hand protection

Wear protective gloves if prolonged or repeated contact is likely. Wear chemical resistant gloves. Recommended: Nitrile gloves. Most gloves provide only a short time of protection before they must be discarded and replaced. #### Skin and body

Use of protective clothing is good industrial practice.
