## Section 6. Accidental release measures

**For emergency responders** Entry into a confined space or poorly ventilated area contaminated with vapour, mist or fume is extremely hazardous without the correct respiratory protective equipment and a safe system of work. ### Methods and material for containment and cleaning up

## Section 7. Handling and storage

### Precautions for safe handling
